Payment Schedule

Sales Prior to July 01, 2023 Deposit

In order to Assign your Primary Booth Choice, you must pay your complete Deposit equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Payment 1 - July 01, 2023

Your next payment is due on or before July 01, 2023 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Payment 2 - September 01, 2023

Your next payment is due on or before September 01, 2023 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Payment 3 - December 01, 2023

Your next and final payment is due on or before December 01, 2023 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Payment 4 - March 01, 2024

Your next and final payment is due on or before March 01, 2024 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Sales Prior to September 01, 2023 Deposit

In order to Assign your Primary Booth Choice, you must pay your complete Deposit equal to 40% of your total Booth Space including, if applicable, Booth Premium.

Payment 1 - September 01, 2023

Your next payment is due on or before September 01, 2023 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Payment 2 - December 01, 2023

Your next and final payment is due on or before December 01, 2023 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Payment 3 - March 01, 2024

Your next and final payment is due on or before March 01, 2024 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Sales Prior to December 01, 2023 Deposit

In order to Assign your Primary Booth Choice, you must pay your complete Deposit equal to 60% of your total Booth Space including, if applicable, Booth Premium.

Payment 1 - December 01, 2023

Your next and final payment is due on or before December 01, 2023 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Payment 2 - March 01, 2024

Your next and final payment is due on or before March 01, 2024 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Sales Prior to March 01, 2024 Deposit

In order to Assign your Primary Booth Choice, you must pay your complete Deposit equal to 80% of your total Booth Space including, if applicable, Booth Premium.

Payment 1 - March 01, 2024

Your next and final payment is due on or before March 01, 2024 equal to 20% of your total Booth Space including, if applicable, Booth Premium.

Sales After March 01. 2024

In order to Assign your Primary Booth Choice, you must pay your complete Deposit equal to 100% of your total Booth Space including, if applicable, Booth Premium.

Reduction of Space

MUST BE IN WRITING AND APPROVED BY OFFICER OF THE COMPANY.

Any Exhibitor requesting a reduction of space will receive a refund of the difference less a 20% Administration Fee of the total refund amount.

Cancelation of Space

MUST BE IN WRITING AND APPROVED BY OFFICER OF THE COMPANY.

Prior to September 1, 2023

Refund will be given in May, 2024 (post show) less a 15% Administration Fee of the total cost of the Booth Space Assignment.

Prior to January 1, 2024

Refund will be given in May, 2024 (post show) less a 25% Administration Fee of the total cost of the Booth Space Assignment.

Prior to March 1, 2024

Refund will be given in May, 2023 (post show) less a 50% Administration Fee of the total cost of the Booth Space Assignment.

After March 1, 2024

No refunds will be given and 100% of the toal cost of the Booth Space Assignment will be forfieted.

No Reduction of Space or Cancelation will be granted after March 01, 2024. Per the ABS 2023 Contract, reviewed and signed, any and all refunds will be processed May, 2024.
