### Important information:

- The marshalling yard does not accept deliveries. This location is only for the staging of trucks delivering to and picking up from event site facilities.
- All carriers delivering to or picking up from the facility must check in at the marshalling yard.
- Drivers will be assigned a number according to check-in time and will be dispatched once dock space is available.
- Please be advised that certified weight tickets are required when checking into the marshalling yard. If weight certificates are not provided then the driver will be dispatched to the closest public truck scale prior to and concluding unloading.

### Inbound marshalling yard information

This show includes a marshalling yard. If you are shipping to show site, make sure to note for your carrier that all carriers must check into the Marshalling Yard before arriving to the show site address and provide this address to your carrier when shipping to show site.

Please ensure your driver has the following information to expedite unloading and delivery to your booth:

### Outbound marshalling yard information

For this event, all carriers must check into the marshalling yard before arriving to the show site address. Please provide this address to your carrier. The marshalling yard hours are:

Friday, February 20, 2026	12:00 PM - 8:00 PM
Saturday, February 21, 2026	6:00 AM - 10:00 AM

### FAQs:

- Where do I check in when I arrive?
  - At the check in office location on the marshalling yard property.
- Is there an entrance fee?
  - No, there is no fee to enter the marshalling yard.
- Is there a scale at the marshalling yard?
  - Yes, there is a scale on-site.
- Can I park my trailer at the marshalling yard during the show?
  - Requests will be evaluated on a case-by-case basis. A waiver of liability would be required for those that are approved and the yard would not be accessible during show open times.
- If I arrive outside of operating hours, is overnight parking permitted?
  - No overnight parking inside the marshalling yard is allowed at this time. Driver would need to find subject to change.

- Exit 3 to merge onto I-805 South toward CA-94 East
- Exit 3 for Main St toward Auto Park Dr
- Turn left onto Main St
- Turn left onto Nirvana Ave
- Turn right onto Energy Way

### From I-805 South

- Continue on I-805 South
- Exit 3 for Main St toward Auto Park Dr
- Turn left onto Main St
- Turn left onto Nirvana Ave
- Turn right onto Energy Way
