



Sample Food and/or Beverage Distribution Request

First & Goal, Inc (FGI) has granted exclusive food and beverage service rights for Lumen Field, Lumen Field Event Center, and WaMu Theater to First & Goal Hospitality (FGH). Sampling food and/or beverage products of any kind may be done only with prior written approval from FGI and FGH, and with the following guidelines followed.

- All items sampled are to be products manufactured, processed, or distributed by the exhibiting firm and must have a relevance to the purpose/focus of the show.
- Any exhibitor wishing to sample a food or beverage product must supply a certificate of insurance for exhibiting with the minimum of \$1,000,000 liability coverage and name First & Goal, Inc. and the Washington State Public Stadium Authority (PSA) as additionally insured. This certificate of insurance must be submitted to FGI at least 20 working days prior to date of event start.
- All samples must be dispensed from and are limited to authorized areas. (i.e. exhibitor's booth, predetermined area)
- All items are limited to sample size quantities and must be distributed according to King County Department of Public Health guidelines.
- **Food samples are limited to bite sized portions (*less than 2 oz or less than 2" x 2" area*).**
- **Non alcoholic drinks are limited to no more than 3.0 fl oz.**
- Food and/or beverage samples that are intended to promote traffic to an exhibitor's booth (i.e. popcorn, coffee) must be purchased directly from FGH and are subject to applicable service fees and taxes.
- No food or beverage may be sold or exchanged for monetary value unless approved in advance.
- Lumen Field and Lumen Field Event Center has granted certain exclusive product rights to our corporate partners. This sampling request may be denied if the product being sampled is deemed to conflict with the rights of a partner.
- Food and beverage related services, including but not limited to storage, delivery, refrigeration, ice, kitchen use, or any other service required to safely maintain or prepare samples is the sole responsibility of the party providing the samples.
- Lumen Field, Lumen Field Event Center, WaMu Theater and FGH care about our environment and have pledged to provide a 100% compostable/recyclable food & beverage distribution to our guests and count on our partners to do so as well.
