We will need a commercial invoice, packing list, Health Certificate, Catch Certificate and correct product labeling. CFI and Kuehne+Nagel will not be responsible for document or labelling errors. Shippers will be held responsible for any shipments that do not clear EU Customs or Vets because of documentation errors.

Shipments are to be delivered to CFI and Kuehne + Nagel packed in insulated boxes that will accommodate dry ice. We will add dry ice to all frozen shipments to insure a 72 hour transit time for US or Canada. Please make sure there is space available for this in each box.

Since we will be shipping from many airports we can supply rate quotes with RESA charges included, but these are estimates as conditions and circumstances can change. CFI and Kuehne + Nagel will be adding the EU Custom charges and RESA charges to our invoicing to shippers. This will give you a complete too booth billing.
