All product needs to be received at Araho Transfer Station between March 10<sup>th</sup> - March 14th to be consolidated onto a truck delivering into the Convention Center.

If needed, J&D can provide local (Boston Area) transportation to Araho.

J&D is a local Boston carrier <u>ONLY</u>, we cannot originate any air shipments, customs clearance and/or long-haul shipments.

For all shipments outside of the Boston area, customers must arrange shipments into Araho themselves

<u>Please note the following steps are critical to proper delivery to the Boston</u>
<u>Convention Center.</u>

We cannot stress the importance of proper paperwork and timely communication.

## **Prior** to shipping your product:

- <u>Label every box/pallet</u> with a proper description of frozen, fresh or dry
- <u>Label every box/pallet</u> with Company Name & Booth number
- <u>Bill of lading sent MUST include:</u> Company name, Booth number, and descriptions (Frozen, Fresh, Dry ETC.)
- Send an email to the below contacts with the following information
  - Company name & booth number
  - How much product- weight & pallet count (if applicable)
  - Type of product (Frozen, Fresh, non-perishable)
  - When your product will be available for pickup
  - o The Delivered Order attached to the email (for airport pickups only)
- Ship all orders to Araho Transfer, 7 Fid Kennedy Ave, Boston Ma, 02210
- J&D Trans and Araho will be working together, so it is very important to email any and all paperwork to all contacts noted below at J&D and Araho:

- All rates will be quoted individually on a per shipment basis by J&D Transportation.
- Invoices will be billed by J&D Transportation and will include all storage and transfer fees at Araho.

## **After delivery to Araho:**

- J&D will arrange for shipments to be consolidated at Araho Transfer with final delivery by J&D Trans to the Boston Convention Center.
- Deliveries to the Convention Center will begin on Wednesday 03/06/2023 and will be delivered by Friday 3/08/23

Please note Overtime Rates on any and all shipments delivered Saturday/Sunday to Boston Convention Center will be charged by Show Management to the customer.

- Your product is delivered into the designated storage area at the Convention Center.
- Any frozen or refrigerated product will be in designated trailers on the loading dock.
- Freeman will have a booth set up on the dock and instruct you where to find your product.
- Someone from your company must claim your product on loading dock.
- J&D cannot deliver any product to your booth ourselves.

Additionally, the show is located in Boston and weather can be unpredictable, we always suggest to ship earlier than later due to inclement weather that may affect deliveries.
