Incentive Rate Deadlines

The Austin Convention Center Department (ACCD) offers an incentive rate to customers who order services in advance.

- Show Management Rate Deadline Show Management will qualify for the incentive rate when orders are requested thirty (30) days prior to the first contracted date of the event.
- Exhibitors Exhibitors qualify for the incentive rate when orders are received online with full payment fourteen (14) days prior to the first contracted date of the event.

Exhibit Utility Service Requirements

- Thirty (30) days prior to the first contracted date of the event, the ACCD Exhibitor Services Division requires a schedule with event move-in, show and move-out times.
- Updated floor plans marked with ACCD floor pockets.
- Updated booth assignment/exhibitor list.

Questions to Think About

- How many exhibitors are expected to participate in the event?
- Who will be the general service contractor?
- Who will distribute the exhibitor kits? Please provide this contact information.

Payment

All charges associated with Utility Services will be included in the final bill from the facility.

Electrical - 120 Volt Power

- Electrical cords provided by the ACCD are single receptacles (one plug).
- Power sources can be supplemented with surge protectors for additional outlets.
- Customers may supply their own surge protectors or purchase surge protectors from ACCD.
- All services are priced for the duration of the event.

Meeting Room/Show Office Power


Use of standard Edison wall outlets in Meeting Rooms and Show Offices is complimentary provided you are self-sufficient in your setup. Charges will apply if ACCD staff are asked to perform the installation or provide additional circuits to the room.

Ballroom/Prefunction Power

- Use of standard Edison wall outlets in Ballrooms and Prefunction space is not permitted.
- Electrical installation in these areas will be performed exclusively by ACCD Staff.
- 208V power is available in select locations.

Labor

- Labor will be charged as follows:
 - o Any four (4) utility services in one (1) booth/space.
 - o Installation of utilities after booth display and/or carpet has been installed.
 - Relocating/moving installed services.
 - Re-taping electrical cords.
 - Resetting breakers due to show management provided equipment.
- Labor (if required) is charged in increments of one (1) hour with a one (1) hour minimum.

Electrical - 208 Volt Power

- ACCD requires electrical services to be installed, operated and maintained in a manner that does not create a hazard to life or property.
- Connecting ACCD wires directly to exhibitor equipment is prohibited. Examples include, but are not limited to, hot tubs, stoves and RVs.
- Electrical rates include bringing the service to the booth from the nearest floor pocket. Does not apply to 200/400 amp services.
- Electrical rates do not include adaptors or special wiring.
- 200/400 amp services are available in specific locations. Client and/or Exhibitor is responsible for providing the cable and rigging services required to connect.
- 200/400 amp services terminate in cam-lock connections.
- If special electrical adaptors or plugs are required, the Client and/or Exhibitor must provide the wiring schematics with required connectors (male & female).
- If adaptors or plugs are not provided, the Client and/or Exhibitor must provide bare-end tails for hardwiring to ACCD's disconnect boxes.
- Clients and/or Exhibitors are responsible for labor charges required to connect and disconnect wires and/or adaptors.

Compressed Air/Water/Drainage

- Compressed air, water, and drainage are available in select floor pockets inside the exhibit hall.
- Water and Drain services are available in certain areas along the building exterior.
- Water connections are delivered via standard 3/4" garden hoses.
- Compressed air hoses are compatible with either 3/8" or 5/8" fittings.
